4. Applicant must be planning to further her education at an accredited college or trade school.
5. **Applicant must provide at least three (3) references from Coaches, Counselors and/or Teachers. (AT LEAST ONE MUST BE FROM A BOWLING COACH).**
6. Submit an essay of 200 words or less (SEE APPLICATION)

The candidate selected by the committee will receive an educational assistance award. **THE AWARD WILL BE DEPOSITED IN THE (USBC) SMART PROGRAM.** (Scholarship Management and Accounting Reports for Tenpins) in the name of the young woman selected. This award will be awarded once to any individual therefore those who have won previously should not apply.
